Are there services covered before you meet your deductible ?	Yes. Most preventive care in-network . Services received at an IHCP or with an IHCP referral are covered at no charge.	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible .
