INSTRUCTIONS FOR USE: Company Medicare Medical Policies serve as guidance for the administration of plan benefits and do not constitute medical advice nor a guarantee of coverage. Company Medicare Medical Policies are reviewed annually to guide the coverage or non-coverage decision-making process for services or procedures in accordance with member benefit contracts (otherwise known as Evidence of Coverage or EOCs) and Centers of Medicare and Medicaid Services (CMS) policies, manuals, and other CMS rules and regulations. In the absence of a CMS coverage determination or specific regulation for a requested service, item or procedure, Company policy criteria or applicable utilization management vendor criteria may be applied. These are based upon published, peer-reviewed scientific evidence and evidence-based clinical practice guidelines that are available as of the last policy update. Coverage decisions are made on the basis of individualized determinations of medical necessity and the experimental or investigational character of the treatment in the individual case. In cases where medical necessity is not established by policy for specific treatment modalities, evidence not previously considered regarding the efficacy of the modality that is presented shall be given consideration to determine if the policy represents current standards of care.

The Company reserves the right to determine the application of Medicare Medical Policies and make revisions to these policies at any time. Any conflict or variance between the EOC and Company Medical Policy will be resolved in favor of the EOC.

MEDICARE COVERAGE CRITERIA

IMPORTANT NOTE: More than one Centers for Medicare and Medicaid Services (CMS) reference may apply to the same health care service, such as when more than one coverage policy is available (e.g., both an NCD and LCD exist). All references listed should be considered for coverage decision-making. The Company uses the most current version of a Medicare reference available at the time of publication; however, these websites are not maintained by the Company, so Medicare references and their corresponding hyperlinks may change at any time. If there is a conflict between the Company Medicare Medical Policy and CMS guidance, the CMS guidance will govern.

NOTES:

 Prior authorization is **not** required for emergent ambulance transports, including air ambulance; however, these may be reviewed post-service to evaluate for medical necessity. (See Policy Guidelines for definition of "emergency.")

IMPORTANT NOTICE: While some services or items may appear medically indicated for an individual, they may also be a direct exclusion of Medicare or the member's benefit plan. Such excluded services or items by Medicare and member EOCs include, but are not limited to, services or procedures considered to be cosmetic, not medical in nature, or those considered not medically reasonable or necessary under *Title XVIII of the Social Security Act, §1862(a)(1)(A)*. If there is uncertainty regarding coverage of a service or item, please review the member EOC or submit a pre-service organization determination request. Note that the Medicare Advance Beneficiary Notice of Noncoverage (ABN) form **cannot** be used for Medicare Advantage members. (Medicare Advance Written Notices of Non-coverage. MLN006266 May 2021)

DOCUMENTATION REQUIREMENTS

BACKGROUND

Ambulance services are covered Medicare benefit under if the following basic conditions are met:

- Actual transportation occurs.
 - (A non-transport claim may be allowed for Medicare Advantage members if the requirements in the member EOC are met [member was treated then released – a no treat/no transport would not be eligible for Medicare Advantage coverage]).
- The member is transported to an appropriate destination.
- The transportation by ambulance must be medically necessary, i.e., the member's medical condition is such that other forms of transportation are medically contraindicated.
- The ambulance provider/supplier meets all applicable vehicle, staffing, billing, and reporting requirements.

The Medicare Benefit Policy Manual reference noted above serves as the primary resource for Medicare coverage of ambulance services; however, additional information can also be found on the <u>local Medicare Administrative Contractor (MAC) - Noridian- web page for ambulance services</u>. This includes, but is not limited to, information regarding coverage (or non-coverage), billing, and Medicare requirements for transport vehicles and their staff.

While this document should **not** be the sole reference for decision-making, the "Ambulance Fee Schedule – Medical Conditions List" may be useful in determining if a particular condition may warrant ambulance transportation, either as an emergency (non-traumatic and traumatic) or non-emergency situation. It should be noted that this document still refers to pre-2015 "ICD-9" diagnosis codes, rather than ICD-10 diagnosis codes, and therefore, a search by diagnosis codes will **not** be useful in searching this document. This document should **not** be used as the sole reference for coverage approvals or denials.

DEFINITIONS

Under Medicare, the terms ground and air ambulance refer to multiple types of vehicles.

- "Ground ambulance" refers to land (automobile) and water transport vehicles.
- "Air ambulance" refers to fixed wing (airplane) and rotary wing (helicopter) aircraft.

Emergency: When the member or other prudent layperson with an average knowledge of health and medicine, believes that presenting medical symptoms require immediate medical attention to prevent loss of life (for pregnant women, this includes loss of an unborn child), loss of a limb or function of a limb, or loss of or serious impairment to a bodily function. The symptoms may be an illness, injury, severe pain, or a medical condition that is quickly getting worse.

BILLING GUIDELINES AND CODING

GENERAL

The codes listed in the table below are not inclusive of all ambulance-related coding. Inclusion of a code does not guarantee coverage or reimbursement, and exclusion of a code is not meant to imply non-coverage.

While HCPCS codes used to report ambulance services may not require prior authorization, they may be subject to utilization audit or post-service review. The coverage criteria in this policy apply to any ambulance service being reviewed, regardless of what HCPCS code is used.

Ambulance services are not paid under the CMS Physician Fee Schedule, but instead are subject to the separate CMS Ambulance Fee schedule.

- Some ambulance services are excluded by Original Medicare, but may be considered a covered benefit by the Plan when called out as a specific benefit under the Member EOC.
- Some codes and services may deny as "not a covered benefit."
- Ambulance A-codes considered to be "covered" services neither means, nor guarantees, separate reimbursement or payment.

*Coding Notes:

• The code list above is provided as a courtesy and may not be all-inclusive. Inclusion or omission of a code from this policy neither implies nor guarantees reimbursement or coverage. Some codes may not require routine review for medical necessity, but they are subject to provider contracts, as well as member benefits, eligibility and potential utilization audit. According to Medicare, "presence of a payment amount in the MPFS and the Medicare physician fee schedule database

(MPFSDB) does not imply that CMS has determined that the service may be covered by Medicare." The issuance of a CPT or HCPCS code or the provision of a payment or fee amount by Medicare does <u>not</u> make a procedure medically reasonable or necessary or a covered benefit by Medicare. (Medicare Claims Processing Manual, Chapter 23 - Fee Schedule Administration and Coding Requirements, §30 - Services Paid Under the Medicare Physician's Fee Schedule, A. Physician's Services)

- All unlisted codes are reviewed for medical necessity, correct coding, and pricing at the claim level. If an unlisted code is submitted for non-covered services addressed in this policy then it will be denied as not covered. If an unlisted code is submitted for potentially covered services addressed in this policy, to avoid post-service denial, prior authorization is recommended.
- See the non-covered and prior authorization lists on the Company <u>Medical Policy, Reimbursement Policy, Pharmacy</u> <u>Policy and Provider Information website</u> for additional information.
- HCPCS/CPT code(s) may be subject to National Correct Coding Initiative (NCCI) procedure-to-procedure (PTP) bundling
 edits and daily maximum edits known as "medically unlikely edits" (MUEs) published by the Centers for Medicare and
 Medicaid Services (CMS). This policy does not take precedence over NCCI edits or MUEs. Please refer to the CMS website
 for coding guidelines and applicable code combinations.
