What is the overall <a href="#">deductible</a> ?	<b>In-Network:</b> \$850/per person \$2,550/per family (3 or more) <b>Out-of-Network:</b> \$2,550/per person \$7,650/per family (3 or more).	Generally, you must pay all of the costs from providers up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the plan, each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. Office visits, most <a href="#">preventive care</a> , emergency and urgent care services.	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply.
