What is the overall <a href="#">deductible</a> ?	<a href="#">In-Network</a> : \$1,500 person / \$3,000 family (2 or more). <a href="#">Out-of-Network</a> : \$3,000 person / \$6,000 family (2 or more).	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the policy, the overall family <a href="#">deductible</a> must be met before the <a href="#">plan</a> begins to pay.
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. Most <a href="#">preventive care in-network</a> .
